## **PAY-OUT POLICY**

Acemoney Intermediaries Private Limited has a dedicated team for processing fund pay-out request received from clients. The client may request for pay-out of the funds as per the below modes.

- 1. Request through phones
- 2. Request through E-mails.

Whenever a pay-out request is received through any of the above mentioned modes, it is forwarded for necessary approval and further processing. Funds are transferred to client's bank account registered with us electronically (NEFT/RTGS/FT), or cheuqe is issued as per the request received. Funds pay-out request is processed in following slots depending upon time of request.

- 1. Request received before 11 am Funds shall be released to the client's bank account by 2 P.M. on same day.
- 2. Request received between 11 am and 4 pm Funds shall be released to the client's bank account by 6 pm on same day.
- 3. Request received after 4 pm –Request shall be processed next day and Funds shall be released to the client's bank account by 2 P.M. on next day.
- 4. on working Saturday request received upto 12.00 PM Request shall be processed on same day and request received after 12.00 PM, the same shall be processed on next working day\*

(\*Request may be postponed to process on next working day due to Server and technical maintenance if scheduled on Saturday)

As per our Company policy, clients need to maintain the minimum balance of Rs. 1000/- in their trading account. Accordingly, all payout requests are subject to a minimum balance of Rs. 1000/- in the trading account except request for closure of account.

In case, Client has updated more than one bank accounts in our records; funds shall be transferred in the Primary bank account as per our records. However, if the transfer of funds gets rejected, then funds may be transferred to another Bank account.
